Author Guidelines

All authors should conform to the following guidelines:

- Use Times New Roman Font throughout the manuscript. The Title of the article should be in 18 pt font size and centered to the page. Author/s names and their affiliations should be in 11 pt font size. Author/s names should be in 11 pt font size. The Remaining text should be typed in Times New Roman 12 pt font size.
- The manuscripts can be written in any of the four languages: Samskrutam, Hindi, Telugu and English
- Devanagari / Sanskrit words should be in 'Shobhika Regular' font. The font may be Shobhika Regular Font - For Devanagari Script - download from the link below.

- The number of words should be less than 7000 words and less than 15 pages including bibliography and profiles.
- Footnotes, if any, should be put at the bottom of the text.
- Brief profile of the authors with a passport size photo should be given at the end of the manuscript after bibliography in 100 - 120 words.
- Plagiarism policy: Every manuscript should accompany a similarity index report in Turnitin plagiarism check software. The similarity percentage should not exceed 10%.
- Plagiarism check shall exclude the following:
 - All quoted work with the necessary permission/attribution.
 - References, Bibliography, table of content, preface and acknowledgments.
 - The generic terms, laws, standard symbols and equations
- **All manuscripts should contain the following information.**

- Title of the manuscript
- List of authors and their affiliations including full name, name of the affiliated institution/organization, email id and full address. Prefix with star mark for the corresponding author.
- List of abbreviations, if any.
- Abstract not exceeding 150 words
- Brief Introduction to the topic of the manuscript
- Detailed description on the subject matter of the topic
- Summary of the manuscript
- Future work on the topic
- Bibliography. List all references serially numbered as their reference appear in the text. All the references should be referred to in the body of the paper at the appropriate level with the serial number of the reference in square brackets.
- The bibliography may include reference books, Journal papers, Conference papers, website urls, and publications by any authentic organizations.
- All the manuscripts shall be authentic and should be supported by Veda PramaaNam. Suitable quotes in samksritam, from Veda Vaangmayam, shall be included at appropriate places in the manuscript to support such authenticity. The term Veda Vaangmayam includes all Veda Samhitas, BrahmaNas, AaraNyakas, Upanishads, Vedāngas, Itihaasaas, PuraNaas, all dharma shastras and sootras, Bhaashyams of all these vaangmaya granthas and reputed Granthas, Kavyas, Kathas, etc written based on these veda vaangmaya granthas.
 - In the case of a research manuscript, describe the present status and research findings.
- For copyright purposes, manuscripts should not have been already published or in the press or accepted in any other forth-coming publications.
- The sender of the manuscript is the person responsible for any copyright violations, in case author and sender are different. Otherwise the corresponding author is responsible for the copyright violations.
- Accepted manuscripts will be published in the first available issue of the journal.
- The Publishers and Editors are not responsible for information (if accepted) or any Copyright violation of any submitted item.
- Acceptance and rejection of Manuscripts: 'Veda Samskruti Samiti' and their 'Editorial Board', reserve their right either to accept or reject any work or manuscript or article or paper, at their sole discretion, without assigning any reasons whatsoever there for, to anyone.
